Gorbachev

- Outline the changes within Soviet society that took place under Gorbachev's leadership.
- 4. Analyse the European-wide implications of Gorbachev's revolutionary policies.

Emperor Hirohito

- 1. Discuss the reasons behind Hirohito's exaltation from war crime convictions.
- 2. To what extent was Hirohito's leadership instrumental in Japanese militarism in the 1940/50's?
- Was Emperor Hirohito a hero of Japanese Imperialism, or an overreaching leader who sacrificed Japanese financial dominance for colonization? Discuss.

Ho Chi Minh

- 1. To what extent did Soviet Russian leadership influence Ho Chi Minh's policy decisions?
- Analyse Ho Chi Minh's role in the Vietnamese defeat of French occupiers in 1954.
- 3. Despite vehemently fighting for Viet Cong in support of a communist North, Ho Chi Minh continuously fought for a united Vietnam. Why was this?

Alexandra Kollontai

1. Examine Kollontai's role in stimulating women's rights across Europe.

- 3. Douglas MacArthur
- 3. What impact did the leadership of Douglas MacArthur have on American victory in the Pacific?
- 4. What response did MacArthur employ to the Japanese attacks on Pearl Harbour?

Golda Meir

- 1. Dubbed the 'First Iron Lady' of international politics, to what extent did her gender influence her leadership?
- 2. Evaluate the success of Meir's leadership throughout the Yom Kippur War.
- 3. Analyse the impact of Meir's leadership on Israeli–Palestinian relations.

Robert Menzies

- 1. Discuss the impact of the 1939 hung parliament on Menzies leadership style.
- 2. To what extent did the growing Communist threat accelerate Menzies return to power?

Albert Speer

- 1. Examine the propagandist impact on German society of Speer's architectural works.
- The German economy was not as prepared for munitions war as the British. Outline Speer's response to this threat.

Achmad Sukarno

- 1. Evaluate Sukarno's role in Indonesia's victory over the Netherlands.
- Outline the failures of Sukarno that became reasons behind the popular Suharto movement and the New Order.



Leon Trotsky

- 1. Justify why Leon Trotsky lost the Soviet leadership race against Stalin.
- 2. Was Leon Trotsky too idealistic and theoretical? Discuss.

Zhu De

- 1. Evaluate the impact of Zhu De's legacy over the People's Liberation Army in their militaristic approach today.
- 2. To what extent was Zhu De instrumental in the victory of the Chinese Communist Party? Compare his role to that of Mao Zedong.

Conflict in IndoChina

- 1. Examine the role of American influence in destabilising Indo-Chinese relations.
- 2. Outline Pol Pot's rise to power and evaluate his subsequent impact on Cambodian society.
- 3. Was the vacuum resultant after the French withdrawal opportunistically recognized by America as a point of future influence? Did American involvement stem from purely humanitarian concerns? Was America genuinely afraid of the Domino Effect? Evaluate the reasons behind American involvement in Indo China.

Arab Israeli Conflict

- 1. Outline the origins of tension between Israel and other Arab states.
 - a. The concept of Arab unity in the 1948 war was a myth. Discuss.
 - b. Discuss the United State's silent response to the 1948 war.
 - c. Why did war break out in 1956?
 - d. The 1967 "Six-Day" War had significant ramifications on Israeli-Arab relations. Discuss.



- 2. Discuss the implications of the Yom Kippur war on Israeli-Palestinian relations.
 - e. The Yom Kippur war was inevitable discuss.
 - f. Discuss the role of Nasser in the outbreak of the Yom Kippur war.
 - g. Discuss the role of the PLO since 1967.
- 3. Analyse America's role in facilitating the Peace Process.
 - h. Was Camp David significant in advancing the Peace Process?
 - i. Outline the impact of the death of Yitzhak Rabin on the peace process.
 - j. How significant were the Oslo Accord in advancing the Peace Process.

- 2. Discuss the implications of Kennedy's Bay of Pigs failure on Soviet-US relations.
- What factors contributed to growing public distrust and resentment towards Communist regimes? In your answer discuss the Berlin Blockade and the Yugoslavian coup.
- 4. Discuss the role of Ronald Reagan, and his policies, during the period of détente.
- 5. To what extent did the arms race facilitate the continuation and renewal of the Cold War?



- 6. To what extend was Gorbachev responsible for the peaceful and violentfree nature of the Soviet collapse?
- 7. Examine the contesting relationship between the Warsaw Pact and NATO in renewing Cold War tensions.
- 8. Was the Cuban Missile Crisis the sole reason for the emergence of Détente?

UN

- 1. Does the lack of genuine fighting capacity hamper the efforts of the UN?
- 2. Examine the influence of the UN in reducing nuclear arms in the 1990's.
- 3. Did the Korean War set a dangerous precedent for Western involvement for future deployments?
- 4. Discuss the impact of the collapse of the USSR on the Balance of Power between the permanent members of the UN Security Council.
- 5. What measures have been implemented to ensure the success of the UN, after the failure of the League of Nations?

French Revolution

- 1. How did conflict between the estates contribute to the development of a revolutionary situation in France in 1789?
- How did failure to reform contribute to a revolutionary situation in France by July 1789?
- Discuss the extent to which difficulties threatened the formation of the new society.
- 4. Using three or four points, explain how the actions taken by urban workers and by peasants between July and August 1789 contributed to the development of the French Revolution. Provide evidence to support your answer.



Renaissance Italy

- Explain how classical ideas were integral to the changes in, and development of, Renaissance art. You can refer to painting and/or sculpture and/or architecture.
- 2. Why was Florence at the heart of the Italian Renaissance?
- 3. What role did the Medici family play in Renaissance Florence?

Chinese Revolution

- Discuss the changes and continuities that the revolution brought about in Chinese societies' values.
- 2. Evaluate whether the revolution was successful in establishing a different set of values that fulfilled the ideals of the revolutionaries?
- 3. How did the Great Leap Forward create a crisis for the revolutionary government?
- 4. To what extent did the Chinese government after 1949 become more authoritarian?'
- 5. 'Mao was extremely successful as a revolutionary but disappointing as a nation builder'. [Jenner, 1992:63].
- 6. To what extent was Mao 'disappointing as a nation builder' after 1976?'

American Revolution

- 1. To what extent did the new society's political structures secure the 'blessings of liberty' for the American people?
- 2. Historians have argued that the American Revolution saw the birth of a nation dedicated to equal opportunity, the rights of the individual, and government.
- 3. Discuss the extent to which you agree with this statement and use evidence to support your argument.





 Discuss the extent to which the American colonies' demand for selfgovernment brought about the events of the American Revolution. Provide evidence to support your answer

Russian Revolution

- 1. Discuss the importance of the Tsar's rule in causing the outbreak of revolutionary sentiment in Russia in February 1917?
- 2. Discuss the extent to which crises and compromise endangered the new Bolshevik regime in Russia. Provide evidence to support your answer.
- 3. Consider Trotsky's assessment below:
- 4. "Had I not been present in 1917 in Petersburg, the October Revolution would still have taken place – on the condition that Lenin was present and in command. If neither Lenin nor I had been present in Petersburg, there would have been no October Revolution: the leadership of the Bolshevik party would have prevented it from occurring."
- Using this statement, discuss why Lenin was an essential factor in the October Revolution.
